

### Did you know?

While the 4th Amendment (see below) protects Americans from illegal searches and seizures, the border of the country has always been somewhat of an exception.

The problem is the Government now considers "THE BORDER" a 100 MILE WIDE AREA surrounding the entire country. 100 Miles inland along the perimeter of the country happens to be home to TWO THIRDS (or 66%) of the Country's population.

This absurd interpretation of our border is allowing Police and Homeland Security to abuse their powers.

This issue is amplified through the inclusion and intrusion of "Big Brother" through new technologies such as Mobile X-Ray devices, Automated Targeting Systems, Identity and Tracking systems utilizing RFID, the WHTI and SBINet and Unmanned Drone aircrafts.



#### **Fourth Amendment:**

**Protection from unreasonable search and seizure.** 

The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no Warrants shall issue, but upon probable cause, supported by Oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.
